THE BUCKINGHAMSHIRE COUNCIL (PUBLIC FOOTPATH NO. 1 (PART) PARISH OF KINGSBROOK) PUBLIC PATH DIVERSION ORDER 2024

On 24 February 2025, Buckinghamshire Council confirmed the above Order made under section 119 of the Highways Act 1980 and section 53A(2) of the Wildlife and Countryside Act 1981.

The effect of the Order as confirmed is to divert the public footpath running from point A on the Order map at SP84397-14576 south south east for approximately 274 metres to point B at SP84608-14264 as shown by a bold continuous line, to a line running from point A on the Order map at SP84397-14576 west south west for approximately 34 metres to point C at SP84369-14557 then south south east for approximately 33 metres to point D at SP84383-14528 as shown by a bold broken line and having a width of 1.8 metres between points A-C and 2 metres between points C-D, and from point E on the Order map at SP84390-14506 south south east for approximately 4 metres to point F at SP84393-14502, then east north east for approximately 8 metres to point G at SP84400-14507, then south east for approximately 42 metres to point H at SP84437-14497, then south south east for approximately 15 metres to point I at SP84446-14485, then west south west for approximately 4 metres to point J at SP84442-14483, then south south east for approximately 116 metres to point K at SP84504-14384, then north east for approximately 120 metres to point L at SP84580-14474, then east north east for approximately 19 metres to point M at SP84597-14476, then south south east for approximately 91 metres to point N at SP84628-14392, then south south west for approximately 18 metres to point O at SP84615-14381, then south south east for approximately 40 metres to point P at SP84627-14342, then south south west for approximately 81 metres to point B at SP84608-14264 as shown by a bold broken line and having a width of 2 metres throughout.

The Order came into force on 3 March 2025, but if a person aggrieved by the Order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from 5 March 2025, make an application to the High Court.
