PUBLIC PATH DIVERSION ORDER 2021**

The above Order, made on 3 November 2021, under section 119 of the Highways Act 1980, and section 53A(2) of the Wildlife and Countryside Act 1981, will divert Public Bridleway No. 43, Chalfont St Giles and part of Public Bridleway No. 5, Chenies running from point A on the Order map at TQ0058-9697 east for approximately 102 metres to point B at TQ0068-9696 then south east for approximately 66 metres to point C at TQ0073-9691 then east for approximately 65 metres to point D at TQ0080-9691 then north east for approximately 58 metres to point E at TQ0084-9694 as shown by a bold black continuous line, to a line running from point F on the Order map at TQ0058-9696 east for approximately 99 metres to point G at TQ0068-9695 then in an east south easterly direction for approximately 153 metres to point H at TQ0082-9690 then north north east for approximately 53 metres to point E at TQ0084-9694 as shown by a bold broken black line and having a width of 3 metres throughout, and Bridle Gate (BS5709) at point F (TQ0058-9696).

Please state the grounds on which they are made.

If no such representations or objections are duly made, or if any so made are withdrawn, Buckinghamshire Council may confirm the Order as an unopposed Order. If the Order is sent to the Secretary of State for Environment, Food and Rural Affairs for confirmation any representations and objections which have not been withdrawn will be sent with the Order. Under the Local Government (Access to Information) Act 1985 this Council is obliged to make any representations received in response to this notice, open to public inspection.
